## New & Noteworthy

### Surveys for Compliance with Omnibus COVID-19 Health Care Staff Vaccination Requirements

Updated requirements from CMS located [here](#).

Items of note:

- Survey Agency's will now only be expected to perform compliance reviews of the staff vaccination requirement **during initial and recertification surveys and in response to specific complaint allegations that allege non-compliance with the staff vaccination requirement**. SAs and AOs are no longer expected to perform these reviews on every survey. This reduction in survey frequency is in keeping with the normal process for oversight of any Medicare requirement, and is supported by the high rates of compliance in initial surveys. Accrediting Organizations retain the authority to exceed Medicare requirements, per their accreditation standards.
- CMS is also reviewing QSO-22-11 to update the interpretive guidance describing Immediate Jeopardy, Condition-level and actual harm determinations to ensure that deficiency citations recognize good faith efforts by providers/suppliers and to more fully evaluate harm or potential harm to patients/residents by considering trends in COVID-19 rates in the community. State Survey Agencies should reach out to their CMS Location if they are considering citing vaccine requirements at immediate jeopardy, Condition or actual harm levels.

### Monkeypox Infection Control Guidance

There are still **0 cases** of monkeypox identified in Montana. However, we wanted to make you aware of the current infection control guidance. DPHHS has developed a [summary document](#) related to infection control practices.

This guidance includes an overview of what monkeypox is, transmission-based precautions, isolation procedures, lab specimen handling, linen handling, environmental cleaning, and waste removal.

Please continue to update EMResource and/or HHS TeleTracking on a daily basis with all required data.

---

### Missed Data in TeleTracking

If a facility misses a day reporting into EMResource and TeleTracking, there is a process for doing a manual entry backdate. Users must log into the TeleTracking then click on Add New Entry. There is now a dropdown where you can choose the date to submit data for. This process is much simpler than uploading the template for missed data. **Ensure that ALL fields are entered or the data will not be counted for compliance.** We still encourage hospitals to enter data into EMResource *daily* by 1200.
